The regular meeting of the Economic Development Commission (EDC) was held Thursday, November 7, 2013, in the Blue Conference Room. Chairman Jim Stock called the meeting to order at 5:30 p.m.

A quorum for tonight's Economic Development Commission meeting was established.

#### **MINUTES:**

#### **Approval of Minutes for October 15, 2013**

Chairman Jim Stock stated the first order of business is the approval of the minutes for October 15, 2013. If there were no additions, corrections or deletions to the minutes he would entertain a motion for approval.

Alderman Marcom moved to approve the Economic Development Commission minutes of October 15, 2013, seconded by Mr. Pecon. **The motion was passed.** 

Acknowledgement of Charlie McCraw's service to the City.

Mr. Pouncey noted that Charlie was a liaison for the Chamber of Commerce (on the Board of Directors for the Chamber of Commerce) to the Economic Development Commission for several years and a member of the Industrial Development Board, a member of Kiwanis and was also on the Board of Directors for GPAC.

#### **REPORTS:**

a) Regional - EDGE (John Lawrence, Manager of Strategic Economic Development Planning) made a presentation. As we have gone through the first phase of this Regional Economic Development Plan that we are doing for Memphis and Shelby County, there are very few people that have the compatibly to exist anywhere in the market that you can tap for this type of work in any constructive work way; if you want it done really quickly. We are moving into the Initiative Development phase trying to build business plans around some lead initiatives. So to see you are reaching out to schools and colleges to help build that compatibly, that goes a long way just seeing that we stay in this process to continue improvements for the long term. We probably will be bringing a consultant in to help us to some degree understand the Innovation and Entrepreneurship eco-system a little bit better. The goal is to align as many of those different economic market levers as we possibly can. He provided an update on the C & N Railroad Project in Pidgeon Industrial Park and said they applied for a Federal Tiger V grant (did not receive). EDGE is the umbrella entity. EDGE taking advantage of an opportunity that has been presented to us. In order for Cargill to expand their facility and to remain here, they really need additional rail infrastructure, so it can run beside the other rail. If that plan is approved by the Board and sent to EDA for their final approval within 30 to 60 days, we may have a \$5 million dollar loan (3 year distribution) for Shelby County businesses ranging in \$50,000 to \$250,000 level for equipment and real estate.

b) WEST TN ECD – (Ordis Copeland, Business Development Consultant, TN Economic Community Development) our goal for last year across the state was to create or find new jobs for TN was 20,000. In December of last year, we met that goal. They increased our goal from 20,000 to 22,000 (10%) increase. We met that goal this month (November) across the state. We have had wonderful success. Our regional part of that has been strong and solid.

City – Germantown Economic Development - Kathleen Rose said we have submitted three grants to EDGE with the Germantown Area of Commerce through a (P3: Public Private Partnership agreement): 1) Economic Development Partnership website the City has now taken that over to retool and redevelop, (<a href="http://www.germantownedp.com">http://www.germantownedp.com</a>) 2) A tourism/visitor's guide, 3) The Germantown Business Industry Summit: January 22, 2014 from 8:00-12:30 at the Great Hall. The keynote speaker is Mark Vitner, Senior Economist, Wells Fargo; the panel will feature Germantown based healthcare facilities, medical technologies and other initiatives, including Baptist Rehabilitation Center, Methodist LeBonheur, Memphis BioWorks, Union University; Quality of Life Community from an Economic Development stand point and will include Orgill; ThyssenKrupp Elevator Manufacturing; Germantown Deputy Chief of Police to talk about Public Safety; Parks and Recreation and the new Board of Education. Ms. Rose updated everyone on the Retail, Tourism, and Innovation Task Forces which met today.

The Tourism Task Force is doing a Tourism/Visitor's Guide that will be done annually for Germantown. We will have a tour in late spring for convention/event planners and hotel managers.

The Innovation Task Force is working on a couple of things, one of which is a draft Public Private Partnership document that has gone to administration for review of a medically related P3.
