INTRODUCTION:

The purpose of this agenda item is to recognize Germantown's Chick-fil-A as the recipient of the April Beautification Commission Business Award.

BACKGROUND:

Chick-fil-A, located at 1230 South Germantown Road, was selected by the Beautification Commission to receive the April Beautification Award. The long-time favorite local restaurant has recently been renovated both inside and out. The new space has expanded seating including an outdoor patio, open floor plan, and a double lane drive thru designed to be fast and efficient.

The restaurant front now faces South Germantown Road and boasts beautiful new landscaping to compliment the site and design of the building. Guests dining on the patio enjoy an evergreen buffer which will grow into a lush green screen to minimize traffic noise. The overall landscape plan includes a wide variety of shrubs and trees with a feature planting of red "Knock Out" roses that are sure to catch the eye. The level of landscape detail, maintenance and care of the property at this Germantown business demonstrates pride in their appearance and their commitment to helping the City look beautiful. The Beautification Commission expressed much appreciation for Chick-fil-A's efforts at their April 7th meeting.

DISCUSSION:

Each month, a designated commission member is responsible for identifying potential award winners and making a recommendation to the Commission. The April commission designee is Jeff Stevbins. Alderman Forrest Owens will present the award to Chick-fil-A's franchised restaurant operator, Anthony House.

SUBJECT:

Germantown Rotary Club Youth Fishing Pond Project

INTRODUCTION:

The purpose of this agenda item is to authorize the Mayor to enter into an agreement with the Germantown Rotary Club authorizing their organization to construct a fishing pier and support amenities at the pond located at the Wolf River Nature Area main trail head, 7014Wolf River Boulevard, as a gift to the City.

BACKGROUND:

For the past two years, staff has been working with the Germantown Rotary Club to identify a possible site to implement a youth educational fishing program. Their goal was to find a pond that could be for "the benefit of children" who wanted to learn how to fish. All of the existing lakes and ponds within the park system have always been open to the public – children and adults, so finding a pond that would not take away a long time fishing tradition for the general public at large was a challenge. Also, it was important that the fishing pond have convenient access and be adjacent to a natural area that could provide opportunities for environmental education as well.

Much consideration was given to all possibilities. With thoughtful discussion, research and assistance from the Ecological Research Center at the University of Memphis, the Wolf River Conservancy and other stakeholders, the lake just west of the Texas Gas transmission line on Wolf River Blvd was selected as the best opportunity to proceed with the concept. The borrow pit lake is approximately 4.5 acres in size, is surrounded by natural vegetation and is adjacent to the Germantown Greenway that parallels the Wolf River.

The Germantown Rotary Club secured a planning firm to design a conceptual site plan for the proposed project. They met with City administration and staff to discuss their proposal. At the Parks and Recreation Commission March 27, 2013 meeting, Jerry Kline and Dr. Phillip Arnoff with the Germantown Rotary Club presented the conceptual plan which was unanimously approved. IRP funding was approved in FY14 in the amount of \$15,000 for the City to construct a connector trail from the fishing pier to the Greenway trail near the River History Plaza interpretive station.

For the past several months, the Germantown Rotary Club has been actively pursuing funding for the project. They have raised \$50,000 towards the project and secured commitments from the Wolf River Conservancy and the Mid-South Fly Fisherman's Association totaling approximately \$45,000. They propose to use this initial funding for Phase I of the project which would include the construction of the first fishing pier, primitive trails on the east and south side of the lake and signage. Long range plans include an additional pier on the west side of the lake, completion of the primitive trail system and a future primitive camp site for youth group overnight stays. Their total project cost is estimated at \$600,000 to be completed as private funding is secured.

DISCUSSION

City staff involved in the planning of this project includes representatives from City Administration, Engineering, Parks and Recreation, the Ranger Division, Public Services and Procurement. Staff is recommending that the City accept their generous offer to provide the resources needed (materials, labor and supervision) to move forward with this project.

The City's legal counsel has worked with the Director of Parks and Recreation and the Procurement Director to draft a written agreement that outlines the obligations and intentions of both the City and the Germantown Rotary Club under such an arrangement (see "Agreement Regarding Pond Improvements" attached). In summary, the Rotary Club is agreeing to provide all resources needed to construct the fishing pier and support amenities as a gift to city in return for the naming rights designation of the site.

VISION 2020:

This agenda supports Vision 2020 in maintaining Germantown as the "preferred place to live" by encouraging and supporting citizens to participate in city projects resulting in enhanced community pride. It additionally supports Vision 2020 through support of organizations taking responsibility for making Germantown a better community through volunteering and contributing resources.

EMPLOYEE SERVICE AWARDS

INTRODUCTION:

The purpose of this agenda item is to request the Board's authorization to purchase fifty-eight (58) gift cards for service years 5 to 35, in the amount of \$12,500.00 from SunTrust Bank (with no service fees).

BACKGROUND:

The City recognizes employee service in 5 year increments, beginning at completion of 5 years and up to 35 years of service. In the past, employees completing 15 years of service received a ring with the Germantown City seal. Beginning this year, the City will recognize employee service increments with gift cards up to \$500 depending upon the years of service. City employees eligible to retire will now receive a ring upon retirement, instead of after fifteen years of service.

From the annual employee survey, the City learned that employees appreciate the gift cards in recognition of service. Employees have the ability to choose how they want to spend the cards and the feedback has been positive. Employees completing service increments of 25 and above also receive a free lunch with the City Administrator and the HR Director.

DISCUSSION:

SunTrust Bank currently provides banking services for the City which includes gift card purchases. Because of the services they currently provide, there is no charge to the City for the gift cards. SunTrust has provided this service since the City began using gift cards for employee service awards and continues to provide quick delivery and an overall seamless process. Typical service charges from other banks range from \$2.00 to \$3.50 per card for an overall savings of \$150-200. Because SunTrust provides banking services for the City, the transaction for the cards is also seamless and is handled through a debit to the City's accounts resulting in savings costs for purchase order and check processing.

INTRODUCTION:

The purpose of this agenda item is to consider approval of Change Order No. 3 in the amount of \$13,047.14 to the contract with Acuff Enterprises d.b.a. Scott Contractors increasing the contract amount from \$19,602,620.24 to \$19,615,667.38 for construction of the Wolf River Boulevard Project.

BACKGROUND:

On January 24, 2011 the City entered into a construction contract for Wolf River Boulevard (WRB) between Kimbrough Road and Farmington Boulevard. Construction began in March of 2011. The project involved construction of approximately two (2) miles of four (4) lane median divided roadway through an environmentally sensitive area. The typical roadway cross-section included two (2) twelve (12) feet wide travel lanes in each direction, a fourteen (14) feet wide raised median landscaped with native plants, and a four (4) feet wide bike lane in each direction. Two (2) signalized intersections, two (2) vehicular bridges, nine (9) major drainage culverts and a pedestrian tunnel were included in the project. By far this was the largest public project the City had ever undertaken and was substantially completed and opened to traffic on August 20, 2013. This project was funded through Local Surface Transportation Program (STP) funds. The City has been reimbursed 80% of construction expenditures. The original construction contract was in the amount of \$18,763,430.24.

Various issues during the more than 2-1/2 years of construction caused the project to go over the original contract amount. The single largest item that increased project cost was fuel escalation. Other items, such as irrigation of the medians and sod, were added to the project at the City's request after construction began. Some quantities in the contract overran, some under-ran. To date accounting of the project is summarized below:

DISCUSSION:

We are in receipt of the contractor's pay estimate in the amount of \$13,047.14 that covers the time period September 2013 through March 31, 2014. This pay estimate includes roadway final quantities for timber guardrail and installation, final pavement markings and signage, street light electrical items, a credit due to overpayment for embankment and all work related to repair of the street failure that occurred in January 2014. BMA approval is needed in order to pay this invoice.

Approval of Change Order No. 3 will increase the contract ceiling from \$19,602,620.24 to \$19,615,667.38. The funds will come from the Wolf River Boulevard Project Closeout budgeted in the City's FY14 CIP. The overage amount is 80% reimbursable.

Staff respectfully recommends approval of Change Order No. 3.

INTRODUCTION:

The purpose of this agenda item is to consider approval of Supplement No. 6 in the amount of \$13,932.48 to the Professional Services Agreement with Smith Seckman and Reid, Inc. (SSR) for additional CEI services related to the Wolf River Boulevard project.

BACKGROUND:

On January 24, 2011 the City entered into a Professional Services agreement in the amount of \$2,999,949.98 with Smith Seckman and Reid (SSR) to provide Construction Engineering and Inspection (CEI) services for the construction of Wolf River Boulevard. The original CEI services provided by SSR included project management and administration, construction inspection, shop drawings review, field surveying, contractor pay application review and submittal and reporting. Throughout the 2-1/2 years of roadway construction, additional services were added to CEI contract. Please see table below for a complete list of supplements to date:

The current ceiling for CEI services is \$3,532,509.26 (80% reimbursable).

DISCUSSION:

Supplement 6, the subject of this agenda item, pertains to the design, quantity calculations and construction inspection efforts related to a street failure that occurred in January 2014. The cause of the failure was traced to moving groundwater in an abandoned stream bed. The repair involved digging out the failed area down to stable soils, placement of underlayment fabric material, backfilling with gravel and replacement of the asphalt and pavement markings. TDOT was informed of the street failure issue and agreed to cover the cost of construction and CEI services at the original contract 80/20 shared responsibility.

SSR's proposal for the design and inspection services is attached.

Approval of Supplement 6 in the amount of \$13,932.48 will increase the ceiling from \$3,532,509.26 to \$3,546,441.74.

Staff respectfully requests BMA approval of Supplement 6.

GERMANTOWN STATION LAKE REFURBISHMENT

INTRODUCTION:

The purpose of this agenda item is to request authorization to contract with Wagner General Contractors, Inc., for refurbishing the Germantown Station Park lake banks, bridges and overflow structure and constructing a walking trail in the not to exceed amount of \$120,000.00.

BACKGROUND:

Germantown Station Lake, located on Laurinburg Circle within the Germantown Station Subdivision, was designed as a water retention basin to control flooding. This lake was incorporated into the 6 acre Germantown Station Park in 1979. The existing concrete spillway has deteriorated allowing the water to fall below desired levels. By reconstructing the spillway and allowing surface water from a grassed area on the south side to drain into the lake the water level in general and the lake edge accessibility will be improved. Trees that are blocking accessibility to the water will be removed.

A five-foot wide by 965 feet long pedestrian walking trail will be constructed creating a loop path that will follow the water edge and connect to Laurinburg Circle in two places. The path will be based with crushed limestone and overlaid with one and a half inches of 411-D hot mix asphalt. The trail will be feathered on each side with crushed limestone. Included in the pathway construction are two bridges over the outfall channel and the lake recharge swale. All disturbed areas from tree removal and regrading will be covered with erosion cloth and over seeded with an approved fescue blend or the area will receive fescue sod.

Two player's benches with backs will be installed along the bank for observation and comfort. The diamond pattern stamped steel benches will be permanently mounted. The seats and backs will be covered in Plastisol with powder coated frames for years of service.

DISCUSSION:

A mandatory pre-bid meeting was held at Germantown Station Park on March 25, 2014 and seven contractors attended. This bid was advertised on the City's website and plan houses. Two qualified bids were received and staff recommends selection of the lowest qualified bid. Alternate two is based on linear feet and Alternates three and four are based on tons needed; therefore, the requested contract amount is not to exceed \$120,000, which will cover the base bid and all alternates. Funding was approved in the FY14 Capital Improvement Budget to refurbish the lake at Germantown Station Park.

VISION 2020:

This project supports the Vision 2020 Quality of Life objective which identifies trails as an avenue for physical fitness and notes the preservation, availability and educational opportunities within City Parks. This project also satisfies lake preservation that provides recreational opportunities for various user groups.

The Public Services Department has a preventive street maintenance program that was established twenty years ago to annually grade, evaluate and schedule the designated streets throughout the City for milling and /or pavement resurfacing. Our annual goal is to prepare and resurface approximately ten center line miles of City streets. In FY13, seven center line miles of roadway were milled and resurfaced under a contract with Standard Construction Company, Inc. in the amount of \$969,339.76.

The annual contract also includes the repair of traffic loops that could be damaged during the milling process, adjustment of water valve boxes, sewer manhole risers and utility boxes. The contract also includes a price for base asphalt mix in the event some structural or foundation failures are discovered. The thermoplastic striping application is included in the annual contract and funded by the Street Striping line item in the State Street Aid Budget.

DISCUSSION:

Per Tennessee Department of Transportation specifications, the asphalt surface is required to be 1.5" in thickness using a 411D surface mix. The FY14 contract surface mix bid unit price is \$74.00 per ton, a \$4.75 per ton decrease from the FY13 bid price. Milling costs per ton are \$10.50, a decrease of \$2.25 per ton from last year. Prior to contract work, Public Services will make all necessary repairs to curbs, inlets, manholes and valves. In preparation for the overlay program, select streets must be milled to protect the integrity of curbs, driveways and drainage characteristics. The bid was advertised on the City website and three qualified bids were received. (Please see attached analysis sheet.) Staff recommends the acceptable low bid on this agenda item. The City has contracted with Lehman Roberts in the past for milling and resurfacing and they have met all contractual requirements.

INTRODUCTION: The purpose of this agenda item is to approve the recommendation of the Germantown Education Foundation to amend the GEF bylaws.

BACKGROUND: The Germantown Education Foundation was created in July 2006 by the Germantown Board of Mayor and Aldermen. The mission of the GEF as described in Article I, Section 2 of the foundation's bylaws is "The Corporation seeks to acquire and distribute resources that will benefit the schools and educational programs in the City of Germantown." Since its inception, the GEF has conducted five grant rounds and has provided nearly \$500,000 to Germantown area schools, with the schools themselves procuring over \$400,000 in matching funds.

DISCUSSION: The GEF Board currently has five directors and is in the process of recruiting additional members who have a passion for education and a desire to support the newly formed Germantown Municipal School District. The current GEF bylaws state "Members of the Board of Directors must be residents of the City of Germantown, Tennessee." On occasion there are board applicants who can be of great assistance to the GEF but reside outside the Germantown city limits. Approval of this amendment would delete this requirement from the bylaws allowing interested and qualified persons, regardless of residency, to serve on the GEF Board. The GEF has unanimously consented in writing to approve the Amended and Restated Bylaws.

VISION 2020: Having "excellent schools - the best in Tennessee" is one of the guiding principles of Vision 2020. Number 4 of the principles states, "City government supports top-quality public schools through financial resources, facilities for school use, enrichment and educational programs, and police presence."
