STAFF'S COMMENTS / DISCUSSIONS REGARDING THE CONSENT AGENDA ITEMS

a. <u>Sprouts market - 3150 Village Shops Drive - Shops of Forest Hill Center - Request Approval of Wall-Mounted Tenant Identification and Tenant Directory Signs.</u>

<u>BACKGROUND</u>: The DRC approved the previous tenant's, Schnucks, wall-mounted tenant identification sign on May 28, 2002. The square footage of the sign was 48.32 square feet. A variance for

an additional 13.125 sign area with the message of "PHARMACY" was approved in August, 2004 for a total wall-mounted sign area of 61.445 square feet.

<u>DISCUSSION</u>: The request to approve a wall-mounted tenant identification and a tenant directory sign is to provide location identification and recognition of a new tenant, Sprout Market, to the Village Shops of Forest Hill. Sprout Market will be locating in the space that was previously Schnucks and initially Seessel's.

The two proposed signs are either below or equal to the maximum sign area permitted by the "SC-1" District. The existing sign policy for Village Shops of Forest Hill permits this site, initially approved as a Kroger, as well as the Target to be governed by individual criteria as approved by the City of Germantown's Design Review Commission.



STAFF COMMENTS:

- 1. The proposed signs conform to the sign requirements for the "SC-1" District.
- 2. The adopted sign policy for the Village Shops of Forest Hill notes that "Signage for "Kroger" (newly proposed Sprout Market) and "Target" shall be governed by the tenant's individual criteria as approved by the City of Germantown".
- 3. The applicant proposes a green background to be placed on the existing ground-mounted Project Directory sign. The existing tenant signs currently located on the directory sign consist of letters mounted directly to the brick background. This sign would be the only one that differs by placing the letters on a colored background frame that is mounted to the brick.
- 4. The letters of the proposed sign are to be white. In accordance with the adopted sign policy, the name of the shopping center on the existing ground-mounted Project Directory sign is an off-white shade known as vanilla bean, which is not quite as bright as a pure white color. The allowance of pure white lettering would impact the aesthetic of the monument sign.
- 5. Prior to DRC approval, the applicant provided a letter of support from the management company of the shopping center indicating their approval of the proposed signage.
- 6. If approved, the applicant must obtain a permit from the Memphis /Shelby County Office of Code Enforcement prior to installing the signs.

<u>PROPOSED MOTION:</u> To approve a sign package for Sprouts Market consisting of a wall-mounted tenant identification sign and a sign on the Project directory sign, subject to staff comments and the documents submitted with the application.





3. <u>Germantown Village Square – 7730 Poplar Avenue – Request Approval of Building Paint Color Selection.</u>


<u>BACKGROUND</u>: At its meeting on July 22, 2014, the DRC approved the paint colors for the repainting of the building containing McAlister Deli and the Bank of Bartlett. The replacement of awnings for that building was approved by the DRC on Sept. 23, 2014.












PAINT SCHEME - PIER I BUILDING FEBRUARY 11, 2015

Mr. John Burgess and Shellie Moses with Boyle Investments confirmed that the color scheme they have on the newly painted buildings (McAlister's, 7710 Poplar Avenue, and Bank of Bartlett, 7708 Poplar Avenue) would stay and are not within the colors that they were requesting the commission to approve tonight.

The commission members explained their concern with the use of the sable color for the store front wall area because it would make it too dark and asked them to try and come up with an alternate color scheme.

Mr. Sherman made a motion to approve the Pier One building at 7730 Poplar Avenue based upon the color scheme presented to us tonight with the understanding that the building that is located to the north which consists of TJ Max all the way down to Office Max will use the same color scheme and colors as presented tonight and will be brought back before us for approval at that time. The sable color is being withheld tonight until they have a chance to review an alternate color scheme for the store front wall area, seconded by Mr. Landweir.

NEW BUSINESS: Amendment to the Ordinance for Accessory Structures.

Mr. Wade Morgan explained that Mr. Joe Nunes, Neighborhood Services has been asked to work on the accessory structure ordinance that would require the applicants to meet the city with certain design elements for accessory structures and size requirements. This is a result of multiple complaints that the Neighborhood Preservation Commission had received concerning the appearance of some existing accessory structures.

The commission requested staff to email them this report so they could read it so as to understand it better and they would contact him with any thoughts they might have.
