This letter herewith transmits the proposed six-year Capital Improvements Program (CIP) for the City of Germantown for fiscal years 2016-2021.

The primary focus of the six-year CIP is to address aging infrastructure and improve service levels for the future. The City employs an annual strategic planning process with the Board of Mayor and Aldermen to focus on the City's vision, goals and objectives, and develop the Policy Agenda for the next fiscal year. The adherence to this discipline every year has allowed Germantown to recognize the principles that define the City's future and ensure that policies, decisions and actions relate to the development of the capital plan.

To address the long-term need for capital projects, a multi-year CIP was developed to address all the various projects to be accomplished during this period of time. This long-term CIP is designed to serve as a planning tool and provide a link between the City's long-range plans, fiscal plan and physical development of the city. The CIP provides for the orderly and systematic financing and acquisition of public improvements.

By identifying necessary projects and needs several years into the future and, in advance of actual needs, several advantages will occur to the City of Germantown.

- Adequate time is available for thorough planning, efficient design, land acquisition, intergovernmental agreements and quality construction.
- Budgeting may take place in a system, which assures that capital projects will be built according to a predetermined priority system, while planning in advance for the revenue needed to finance and complete these capital projects.
- This process permits major purchases to be scheduled commensurate with favorable market conditions.
- Coordination with the operating budget is maximized. An important aspect of the CIP is the effect capital expenditures have upon the annual operating cost of the City.

### CIP AREAS


One major portion of this year's CIP includes key major transportation improvement projects which provide connectivity and ease of movement within the city. Additionally, this year's program includes a number of planned drainage improvement projects around the city, which will provide stream bank stabilization and protection to our residents from flooding problems. Other significant capital projects include improvements to the Athletic Club and the Great Hall. In addition, the Safe Routes to Schools and Central Business Center Landscape projects will enhance Germantown's quality of life and ties directly to the Board of Mayor and Aldermen's long-range goals.

### CIP FUNDING

Germantown's Capital Budget is increasingly difficult to complete due to a growing number of beneficial projects, which require funding. General Fund reserves continue to be utilized to fund capital projects. There are two basic approaches to funding capital projects. These are pay-as-you-go and pay-as-you-use. Pay-as-you-go means paying for the capital project


out of current revenues at the time of expenditure. Pay-as-you-use means borrowing to finance the expenditure with debt service payments generated from revenues raised through the useful life of the project. Many capital budgets use a mix of these two financing methods, and Germantown is no exception. Germantown has traditionally used a mix of approaches to finance capital projects.

Capital projects are funded through bonds, reserves, grants, developer contributions and other governmental sources. FY16 continues the dedication of state Hall Income and Excise (Hall) tax revenue to fund capital improvements program projects. Therefore, allowing the city to earmark a specific funding source for pay-as-you-go project funding.

Approximately \$3.54 million in General Obligation (G.O.) bond funding is identified in the six-year planning period. Contributions from intergovernmental sources will total \$8.19 million during the next six years. The Board of Mayor and Aldermen and City Administration have worked closely with State officials to obtain funding for costly street and intersection improvements. The success of the Board's efforts has created valuable funding opportunities for other projects.

# CITY OF GERMANTOWN

## Germantown, Tennessee

The City of Germantown's six-year Capital Improvements Program (CIP) includes projects to provide the community with drainage protection, improved parklands and greenway, expansion of roadways and general community enhancements. The funding sources for these projects were determined based on sound financial planning and a fiscal impact analysis.

### FINANCIAL POLICY

The following is the capital section of the City of Germantown's financial policies. The financial policies are to provide guidance to Administration in budgeting, long-range planning and financial management of the City's operations designation for the General Fund balance.

#### **Capital Improvements Program**

The Capital Improvements Program (CIP) will reflect a consensus of the perceived needs and desires of the community based on current surveys and long-range planning. The CIP will be cognizant of the financial impact on the applicable fiscal year and the City's past, present and future goals. The CIP will generally address those capital projects used for the acquisition or construction of major capital facilities.

The City will update and adopt annually a six-year CIP, including the annual Capital Improvements Budget (CIB) and a five year projection of capital needs and expenditures which details the estimated cost, description and anticipated funding sources for capital projects. Projections may be made for future projects exceeding the six-year CIP timeframe. The plan will include costs that have been estimated including consideration for inflation. The inflation rate will be determined annually in the budget process and will be disclosed in the capital budget report.

The first year of the six-year CIP will be the basis of formal fiscal year appropriations during the annual budget process. As part of the annual budget process, the CIP will be evaluated and adjusted with changes in priorities. The Mayor and City Administrator will review the CIP quarterly and if new project needs arise during the year, a budget adjustment identifying both the funding sources and project appropriations must be presented to the Board of Mayor and Aldermen (BMA) for approval. The approval must occur before active progress is made on the planning, design, or construction of the project. Projects may be granted exceptions as to promptly resolve any dangers to the community.

Projects involving development contracts brought before the Board of Mayor and Aldermen for approval during the operating year will identify proposed sources of funding and impacts to CIP funding, in particular, the General Fund Operating Reserves.

Each capital project will have a "sunset provision" enforced at the end of the fiscal year, which can only be lifted by resolution adopted by the Board of Mayor and Aldermen.

Projects will be monitored to ensure compliance with CIP Policy and Procedures. Projects will be entered into a timeline to produce a CIP schedule. Post-project evaluation reports will be used to determine the successfulness of a project.

### Evaluation Criteria

In order for a project to be considered in the CIP, an application shall be submitted for evaluation. A CIP Committee will be developed to assist in the review of project applications. The CIP Committee will use the following criteria to evaluate each capital project:

1. Conforms to the City's Strategic Plan
2. Supports the BMA Policy as adopted in January of each year
3. Promotes safety and security
4. Requirements to meet federal or state mandates
5. Availability of federal or state funding assistance
6. Savings in operating, capital spending or energy consumption
7. Impacts to future operating costs
8. Enhances economic development or adds to the tax base
9. Deferring will have possible significant implications for the community
10. Maintains a current level of service
11. Improves the quality of existing services
12. Relates to another high priority project or is a continuation of a project currently under way
13. Replaces or maintains a capital asset
14. Creates a disruption or inconvenience to citizens
15. Benefits a large amount of stakeholders
16. Carries risk or uncertainty
17. Protects or contributes to the history of the City
18. Project timeline
19. How does the project impact the City's Triple Bottom Line; Economic, Environmental & Social Sustainability

## FUNDING OPTIONS

The City of Germantown uses a combination of the pay-as-you-go and the pay-as-you-use approaches to funding the CIP. Capital projects are funded through bonds, reserves, grants, development contributions and other governmental sources.

### Bonds

Long-term general obligation bonds are issued to correspond with the start of a project, maximize market conditions and fund projects with a life expectancy of at least the term of the bond.

Bonds are usually general obligation for the majority of the bond projects. It is preferable that the total amount of debt issuance in a calendar year is below \$5,000,000, thereby allowing the City to qualify as a small issuer exception. A small issuer exception as permitted by federal arbitrage regulation is exempt from having to rebate excess investment earnings to the federal government. An analysis of debt burden, both direct and overlapping, is conducted in planning bond issuances to ensure the fiscal stability of the City and triple-A rating from Moody's Investors Service and Standard & Poor's.

### Reserves

General Fund – Reserves funding is the provision of cash as the result of excess General Fund operating revenues over General Fund operating expenditures.

Hall – Hall funding is the dedication of the Hall Income and Excise Tax revenues to fund capital projects. In FY04, the City established the Hall Income and Excise Tax revenues as "earmarked" to capital projects due to the uncertainty of this state-shared revenue source.

Utility – The Utility Fund accounts for water and sewer fees in connection with the operation of the City's water and sewer system. The proceeds of several bond issues and intergovernmental loans have been used specifically for the construction or acquisition of water and sewer systems and facilities.

Germantown Centre Fund – The Germantown Centre Fund accounts for Centre recreation and aquatics programs fees in connection with the operation of the Germantown Centre. The proceeds of a general fund bond issue and, most recently, an intergovernmental loan have been used for the construction of the Centre.

### **Grants**

Funding is available from various county, state and federal agencies including Tennessee Department of Transportation (TDOT), Environmental Protection Agency (EPA), Federal Congestion Mitigation and Air Quality (CMAQ) and Department of Conservation.

### **Development Contribution**

This funding source is assumed to be available from developers in a specific area for a specific project. It is anticipated that as property is developed, the developers will fund their fair share of the CIP project. The City may construct projects in an area prior to development. In such cases, only water lines and traffic signal reimbursements have been required from developers.

### **Other Governmental Sources**

State/Federal – Funding for these capital projects is the full responsibility of a federal or state agency. The City of Germantown is only responsible for the coordination of the capital project due to it being within Germantown's borders. These funds are not accounted for in the six category totals, since the City of Germantown will not appropriate the funding.

## **BOND ISSUANCES**

FY16 G.O. Bond Issue (\$2,204,000) – The FY16 bond issue includes Lateral G drainage improvements (\$1,100,000); Grove Park outfall improvements (\$210,000); Cameron Brown Park drainage improvements (\$210,000); Greenway Phase 6 construction (\$340,000) and Wolf River Boulevard milling and paving (\$344,000).

FY17 G.O. Bond Issue (\$1,340,000) – The FY17 bond issue includes Lateral G drainage improvements (\$1,100,000) and Germantown Road Realignment (\$240,000).

## **SUMMARY**

The CIP is reviewed and updated annually during the budgetary process to incorporate any changes in cost estimates, funding priorities, economic conditions and policy direction. It is anticipated that the revenue base, dedication of the Hall Income and Excise tax revenues, bond issuance schedule and forecast of operating budgets will be sufficient to support the CIP and ensure the strong financial stability of the City of Germantown.

**RESOLUTION ESTABLISHING A CAPITAL IMPROVEMENTS PROGRAM

**WHEREAS**, it has been determined by the Board of Mayor and Aldermen that it is necessary and desirable to have a six year Capital Improvements Program to provide for orderly and systematic financing and acquisition of public improvements; and

**WHEREAS**, Ordinance No. 2015-2, which is the fiscal year 2016 Budget, includes programs which must be completed in future years and those programs are incorporated herein; and

**WHEREAS**, it is the City's intention to update said Capital Improvements Program each year by including in the operating budget that section applying to the next fiscal year operating budget;

**NOW, THEREFORE, BE IT RESOLVED** by the Board of Mayor and Aldermen of the City of Germantown, Tennessee;


