SUBJECT: GPAC THEATER CURTAINS

INTRODUCTION:

The purpose of this agenda item is to consider approval to purchase theater curtains from Georgia Stage, LLC in the amount of \$13,680.00 to replace a portion of the theater curtains at GPAC.

BACKGROUND:

As part of the 2016 IRP Budget Process, funding was approved to replace the outdated theater curtains. This is the first purchase of a four year purchasing program that will eventually replace all of the theater curtains at the venue. Theater curtains should be replaced every ten to fifteen years. The curtains currently in GPAC were installed 21 years ago and show multiple signs of disrepair. The total award amount includes: Ten (10) Black Leg Curtain Panels and Twenty-four (24) Border Panels.

DISCUSSION:

The City received four (4) bids for the Germantown Performing Arts Center theater curtains. Although Georgia Stage, LLC took an exception to the acceptable brands of fabric, after further review of the fabric by the requesting department it was determined that the fabric is an acceptable equal product.

Georgia Stage, LLC has met all the requirements in submitting a properly completed bid package and has been deemed the most responsive and responsible bidder. The bid was advertised on the City of Germantown website, and an e-notification was sent to eight hundred seventy- one (871) vendors. Georgia Stage, LLC has been in business since 1990 and is family-owned and operated, all custom drapery is sewn on site. The following are just a few of the venues listed in their portfolio; Fox Theatre, Atlanta, GA, Shreveport Municipal Auditorium, Shreveport, LA and Yale University, New Haven, CT.

Nolan's Production Group will handle the installation of the curtains for an additional fee.

VISION 2020:

This project supports the Financial Sustainability Goal 22 of maintaining and upgrading City facilities and the implementation of the 2005-2006 City Facility and Capital Assets Action Strategy.

BACKGROUND:

The Germantown Education Foundation is a 501(c)3 organization formed by the City of Germantown in 2007 as a mechanism to raise funds for academic purposes. In 2011 the City suspended the provision of general fund dollars to the Foundation pending the formation of the Germantown Municipal School District.

DISCUSSION:

The FY16 budget provides for the allocation of \$100,000.00 from the City to support the activities of the Foundation. Action by the Board of Mayor and Aldermen is necessary to move these funds from the civic support line item to the Foundation.

VISION 2020:

This grant is in keeping with Vision 2020, Quality of Life, Lifelong Learning, Goal 17: Objective 3 – Education resources for youth offered by our City to public, private schools, and home schooled children, and Objective 9 – City support quality public education providing financial resources.

Contract Street Sweeping

INTRODUCTION:

The purpose of this agenda item is to authorize the Mayor to enter into the first year of a three year contract with two option years with Sweeping Corporation of America for contract sweeping services in an amount not to exceed \$212,834.14.

BACKGROUND:

The City has utilized contract sweeping services with great success for over 25 years. Sweeping Corporation of America has been the contractor for the last four years, purchasing the contract from Simmons Sweeping Company in June of 2011. In the past few contracts, the city has implemented five year service agreements (three years with two additional option years) and the process has been efficient and economically beneficial. Sweeping Corporation has provided good service and the working relationship has been exemplary throughout the last four years.

DISCUSSION:

A non-mandatory pre-bid meeting was held on September 29, 2015 and Sweeping Corporation of America attended. The bids were opened on October 7 and two bids were received. Public Works officials met with the apparent low bidder, Airfield, Etc., to discuss irregularities with their bid submittal. In a later statement from the company president, Airfield Etc. confirmed that there was an error in the mileage estimates that would prohibit Airfield, Etc. from meeting the contractual obligations required in the specifications.

Staff recommends acceptance of the Alternate Bid which provides for disposal of contractor-generated debris from sweeping during the heavy leaf season (November – February) at the Public Works Complex. The savings realized from the sweeping contract are significant (\$67,656) compared to Public Works transporting the debris with larger trucks to the Frank Road landfill (\$17,000). Accepting the Alternate Bid saves approximately \$50,000 annually.

The contract will continue to provide contract sweeping service on a weekly basis for commercial routes, bi-weekly for high volume traffic corridors, monthly for major collector routes and six times annually for designated residential areas that are heavily wooded or potentially flood prone areas. In addition, this contract will continue city wide sweeps for a maximum of two times per year or as the seasons dictate the need. This service provides for aesthetic roadways, extended surface life of each street and the reduction of storm water inlet stoppages and pollution run off. Over 2,500 yards of debris were diverted from our storm water collection system last year. The Storm Water Operations Budget will provide the funding for this contract.

SUBJECT:

TRANSITIONAL REINSURANCE PROGRAM PAYMENT

INTRODUCTION:

The purpose of this agenda item is to authorize the full payment in the amount of \$33,101.64 to Health Cost Solutions/Pay.gov for the 2015 benefit year to the government for the transitional reinsurance program as required by the Affordable Care Act.

BACKGROUND:

To fund many of the changes and programs mandated by the Affordable Care Act several new taxes and fees are impacting traditional insurance plans and self-funded plans (like the City of Germantown) across the country. One such program change was the establishment of the Transitional Reinsurance Program. Through this program, reinsurance fees are distributed to health insurance providers such as the exchanges and the health insurance marketplace. The assumption is that insurance purchased through these providers may disproportionately attract individuals at risk for high medical cost. This reinsurance program is designed to protect these companies from losses and help stabilize premiums.

DISCUSSION:

This is the second year of a three-year program. The program is funded over a three-year period through a transitional reinsurance assessment on health plan sponsors in the amount of \$20 billion and contributions from the US Treasury at \$5 billion. In 2015 the reinsurance fee for traditional insurance plans and self-funded plans is \$44.00 per member per year times our average plan enrollment of 752.31 equals \$33,101.64.

Self-funded plans, which applies to the City of Germantown, must ensure the reporting, as well as scheduling of the payment, is completed by November 10th. Health Cost Solutions, the city's third party administrator, will file the form and schedule the payment by November 10th, for all clients at no cost. The City has availed itself of the option of allowing the TPA to make the payment. Most HCS clients, including the City, are accepting this option, to ensure the form and payment is correct and sent in a timely fashion.
