# ECONOMIC DEVELOPMENT COMMISSION Thursday, August 4, 2016 Blue Conference Room 1930 South Germantown Road

The regular meeting of the Economic Development Commission (EDC) was held Thursday, August 4, 2016, in the Blue Conference Room. Chairman Klein called the meeting to order at 5:30 p.m.

1. A quorum for tonight's Economic Development Commission meeting was met.

# 2. Minutes: Approval of Minutes for July 7, 2016:

Chairman Klein stated the first order of business is the approval of the minutes for July 7, 2016. If there were no additions, corrections or deletions to the minutes, he would entertain a motion for approval.

Mr. Towne moved to approve the Economic Development Commission minutes of July 7, 2016, seconded by Mr. Pecon. **The motion was passed.** 

## 3. <u>Reports/Monthly/Quarterly:</u>

a) Reid Dulberger, Chief Economic Development Officer for Shelby County EDGE gave a quarterly report on activities within the County. The most interesting new things we have going on is a University District TIF commercial project public improvements along Highland Street in the area of the university between Poplar Avenue and Park Avenue. This would be the first Tax Increment Financing in Shelby County used in that way. It's for public improvements such as roads, sidewalks, crosswalks, signage, lights, utilities, and gutters. We, as a community, have used the Uptown TIF in Memphis, which has been around since 2000; we used the Graceland TIF where the money is going into the Graceland project (hotel), the state approved the tourist and development zone in 2014. We have been put in place financing of \$128 million of bonds for the hotel. The hotel will open in two months. It has 450 rooms, theatre, two restaurants, 50,000 square feet of meeting space, and indoor and outdoor swimming pools. Then, the second piece is Elvis Past, Present, and Future development, which is on the other side of the street from the hotel. There will be 220,000 square feet of retail and exposition space in March of 2017. The Millington TIF went into a parking lot and into a retail plaza. The Highland Road project is going to have a garage. We think there might be a lot of use for a project like this. The relocation of Service Master Project downtown will retain 965 direct jobs, which pays over \$95,000 a year. There are 1200 total jobs with contracts. We, as a community, put a lot of cash on the table, and the State put \$5.5 million of cash in and we put \$2.3 million in. A Downtown Commission affiliate arm put in \$1 million cash and a thousand free parking spaces for 20 years.

We are working with St. Jude, ALSAC, and the City on the St. Jude expansion. It's about a billion dollars of real property investment with 2000 jobs. The City of Memphis will put in \$100 million of public improvements in the area of east, west, and north of St. Jude.

We also have a pot of money from the City of Memphis that we will use for (ICED) Inner City Economic Development loans. These are between \$5,000 and \$25,000 of forgivable loans to inner city businesses and neighborhood businesses. We like to put the money into façade and things that

will remain at the business. It improves the vision aspect of the community. We have approved three of these totaling just over a \$1 million.

We have completed a strategic plan for EDGE. The plan has called for improvements for internal working, but it also identifies five areas of work and industry. We run the Port Commission and then also, neighborhood revitalization, small businesses development and encouraging regional collaboration.

**b**) Ms. Lisco stated that TVA has notified that the City will maintain its platinum Sustainable Community designation.

Ms. Lisco reported that she attended an economic development training session by (DRA) Delta Regional Authority in Alamo, TN. The DRA session had presenters who were members of (IEDC) International Economic Development Council who spoke about marketing and attraction, to business retention and expansion, and entrepreneurship. She also attended the (SEDC) Southern Economic Development Council's annual meeting. Their focus, being in Kansas City, MO, was innovation. Kansas City has the Kauffman Foundation which does a lot of research as well as funding for different entrepreneur programs. With the incubator here, she chose the entrepreneurial sessions as there was always someone with the Kauffman Foundation on each panel. On July 17, the Meet Your Maker II event was held at EPIcenter Germantown. The Made By Project did a Facebook poll and found out Sunday was the preferred day. They have since conducted a few more of these meetings, along with a survey to find people which have these types of interest to determine what resources they are looking for county wide. They had about 30 people attend. The survey just wrapped up and once they get that information together, they will meet with us and let us know about the strength of the group in Germantown.

Ms. Lisco noted that on July 26, EPIcenter Germantown had its Half Birthday Party. We really had a good turnout. Mayor Mike Palazzolo and Leslie Lynn Smith, President of EPIcenter, spoke and they got a new tenant to sign up that day. On August 13, they are going to have an HTML coding class. On September 21, they are going to have some of the CoStarters curriculum presented. I encourage you, if you are ever interested in going between 9:00-12:00 it is staffed by CoWork Memphis, EPIcenter, or us. We try to rotate the calendar.

Mr. Ross noted there are some changes in the short term rental ordinance. It had a third reading on August 8, which was related to vacation rental services like Airbnb. It limits the ability to rent those out by the night here in Germantown. It would be a minimum 30 day rental. Brentwood, TN limits it to 90 days. The final third reading for a cell tower height extension will be heard at the BMA on August 8. It will go from its current 100 foot height limit to a 140 foot height limit which modifies the area called the "fall zone" (which was 100 feet with an additional 10 feet it had to clear in case it fell over…like a tree falling over at its base rather than crumble). If the tower builder can illustrate through engineering that the tower will crumble, they only have to cover that area. They don't have to cover 150 feet. So, hopefully, that will increase interest in going higher in other places.

### c) Planning/Small Area Plan - Nodes/Districts:

- i. Central Business District Traders Joes' revised site plan was approved at the Planning Commission on August 2. This is also a good opportunity to state that the Trader Joes' official website is now announcing a store opening in 2017 at 2130 Exeter Road in Germantown, Tennessee. They just changed the way the parking lot functions and moved the loading dock from the north side of the old Kroger building to the east side behind the Kroger building, so it could function better for three tenants who would be going into the former Kroger space. There was some discussion about the loading dock backing up to them. The applicant demonstrated that a grocery store traditionally gets 18 to 20 deliveries a day from the produce, meat, beer, bread, coke, etc trucks. Whereas, retail may get 6 to 8 deliveries a week during the Thanksgiving and Christmas season. A retail store may get one truck a week with some daily deliveries that happen from the UPS, FedEx truck that goes to the front door.
- ii. East Poplar Avenue (at Forest Hill-Irene) The Planning Commission approved a new office building to go into that last open lot on Forest Hill Irene next to the Fire Station four. It will be

a full office building that will take up that last lot for the Grant family business...I think it's Grant Homes for Milton Grant.

- iii. West Poplar Avenue District We will be taking the TraVure Development Agreement to the BMA on August 22 for a vote so they can go ahead start their work.
- iv. Wolf River –Most of the interest up there is trying to figure out how to get some of the projects started and what's going to happen at the end of Wolf Trail Cove. A land owner is trying to figure out the best way to utilize his space next to the greenway.
- v. Forest Hill Heights The third reading for the Forest Hill Heights Smart Code zoning overlay will be August 8 at the BMA meeting. We hope, based on the previous two readings, it will pass so that it will go into effect and we start to see some action down there. We have had several groups come in to look at that area and they showed some interest locally and out of town. We decided to go the simple route and apply T5 (five stories) by right (six stories by warrant) on the larger section south of Winchester, and T3 and T4 on the smaller sections north of Winchester so it could be more in line with the existing development.
- **d**) **Germantown Area Chamber of Commerce**: Janie Day gave a report from the Germantown Area Chamber of Commerce:


#### Taste of the Town
