## Certificate of Achievement for Excellence in Financial Reporting

# ROW Acquisition -Tract 21 - Wolf River Boulevard/Germantown Road Intersection Improvements Project and Resolution 17R14

The purpose of this agenda item is to authorize the City of Germantown and the State of Tennessee to acquire from Wolf Trail Cove, LLC the property and interests described in Exhibit A by exercise of the right of eminent domain vested in the City and State for the purchase price of \$74,020.00 or such other amount as may be found to be due by the Courts to the owner for the acquisition of real estate and/or easements related to improvements to the intersection of Germantown Road and Wolf River Boulevard and to approve Resolution No. 17-R14.

Mr. Gwaltney, City Engineer, stated that the intersection of Wolf River Boulevard and Germantown Road (S.R. 177) is one of the most heavily congested intersections within the entire Memphis-MPO area. The latest available volume counts indicate an Annual Average Daily Traffic (AADT) of over 75,000 vehicles per day. Excessive delays at all times of the day prompted the City of Germantown to request federal and state funding for improvements to add capacity and increase efficiency of the intersection.

In order to meet the City and the State's goals of a safer, more efficient intersection, widening to accommodate additional laneage is required. In order to widen the roadway, acquisition of right-of-way (ROW) from private property owners is required. ROW appraisals and offers to property owners are currently taking place. We anticipate acquiring the necessary ROW in FY18. Construction is expected to begin in FY19.

The City requested funding for the project utilizing Surface Transportation Program (STP) funds through the Memphis-MPO. The project ranked sufficiently high to be funded in the previous (2014-2017) and current (2017-2020) Transportation Improvement Program (TIP). Typically, STP projects are 80% federal/20% local responsibility. However, since the bulk of the project is on a state route, TDOT has agreed to cover the 20% local match requirement. Therefore, the City has been and will continue to be reimbursed 100% of all project expenditures.

The City received a notice to proceed to the PE-NEPA (environmental) phase in March 2014. That phase was completed in late calendar year 2014. The City then received a notice to proceed to the PE-DES (design) phase in December of 2014. That phase was completed in early calendar year 2016. The city was then issued a notice to proceed to the right-of-way (ROW) phase of the project in June 2016.

At that point, the City entered into professional services agreements (PSA's) with a property appraiser (Bouldin and Associates), an appraiser reviewer (Doug Hall & Associates) and a negotiator (Stanfield Consultants). A total of twenty-seven (27) properties are involved on this project. To date, appraisals and reviews have been completed on twenty-four (24) of the properties. Offers have been extended to owners of twenty (20) of the properties.

Consistent with TDOT requirements, an appraisal of all rights-of-way and easements was performed by Bouldin and Associates (Mr. Earl Randle Bouldin, Jr., MAI, SRA, AI-GRS, CCIM). A review of the appraisals was conducted by Douglas B. Hall. The offer to property owner was made by third party negotiator Mr. Andrew F. Miller of Stanfield Consultants.

As indicated in the titled Appraisal for Tract 21, the area and improvements to be acquired on a portion of Tract 21 were valued at a total of \$74,020.00. The owner of Tract 21, Wolf Trail Cove, LLC, was offered this amount. The owner has declined the offer.

Motion by Mr. Janda, seconded by Ms. Gibson, to approve Resolution 17-R14 authorizing the City of Germantown and State of Tennessee to acquire by eminent domain from Wolf Trail Cove, LLC the property described in Exhibit A for the total lump sum amount of \$74,020.00 or such other amounts as found to be due by the Court to the owner for Germantown Road/Wolf River intersection and improvements; authorizing the City Attorney and Attorney General to proceed with condemnation and authorizing the City to pay said sums to the Court as may be required.

## **Contract - GPS Contract One Year Extension**

This system provides the ability to identify unnecessary idle time, unauthorized vehicle use, real time location of vehicles, identify underutilized vehicles, assist drivers in emergency situations, and possibly reduce insurance cost and other liability situations.

MOTION: To approve a one (1) year extension for the GPS annual service fee with LB Telematics utilizing the Tennessee SWC 199 in the amount of \$45,015.75.

An appraisal of all rights-of-way and easements on Tract 25 was performed. The fair market value of the property to be acquired was determined to be \$26,026.00 and 64 LTD, LLC accepted the offer.
