Call to Order

The Mayor called the meeting to order.

Set Agenda

Grant - GPAC Arts Education

Committed to careful stewardship of City funds, GPAC established guidelines and criteria consistent with Tennessee Arts Commission standards, developed an online application system and created a grant-awarding

process. In 2015, GPAC created the GPAC Arts Education Fund, which supports several arts education programs and grants.

Motion by Ms. Gibson, seconded by Mr. Barzizza, to approve the transfer of funds to the Germantown Performing Arts Center in the amount of \$40,000.00 for the purpose of issuing grants to school art programs and community arts groups.

CONSENT

Contract Extension – Street Sweeping

Sweeping Corporation of America has been the contractor for the last seven years. In the past few contracts, the City has implemented five year service agreements (three years with two additional option years) and the process has been efficient and economically beneficial. Sweeping Corporation has provided good service and the working relationship has been exemplary throughout the last seven years.

MOTION: To authorize the Mayor to enter into the first year extension (at the City's option) with Sweeping Corporation of America for sweeping services in an amount not to exceed \$119,271.00.

Donations - Germantown Community Library

The Germantown Community Library works in partnership with many local organizations and individuals to provide top quality services to its patrons. A donation of \$4,000.00 was designated by the Friends to be split three ways: \$1,400.00 for supporting programs and supplies for The Big Read, \$1,500.00 for marketing library programs and events and \$1,100.00 for supporting the library director's Every Book Counts initiative. The Germantown Women's Club also offers steady support to the library. The Club's donation of \$1,230.00 has been designated as follows: \$1,000.00 for the enhancement of children's programs and \$230.00 towards the purchase of large print materials for the library's collection. The funds given by Germantown Women's Club members Sharon Goldsworthy, Alys Drake, June Boswell, Dorrie Jean Simms, Mrs. David Jeter, S.E. McCulloch and the anonymous donor were also designated to enhance the large print collection.

MOTION: To approve donations of \$5,470.00 to the Germantown Community Library and to approve Budget

Donation - Germantown Education Foundation - Friend of the Foundation - 1st Quarter

At a retreat in 2014, the Board of Mayor and Aldermen established, as one of their objectives, the opportunity for Germantown citizens to donate funds to the Germantown Education Foundation through their monthly water bill. Friend of the Foundation originally established as "Fill the Fountain of Knowledge," currently has 213 recurring donors.

MOTION: To approve the transfer of funds collected by the City from residents and others to the Germantown Education Foundation in the amount of \$4,141.00.

Contract Addendum – Employee Performance Management Software

In September 2015, the Board of Mayor and Aldermen approved the acquisition of NeoGov Insight applicant tracking system, which guides job seekers to apply online for posted open positions. This electronic upgrade will align individual and departmental team objectives with organizational strategies to manage both employee performance and career goals. This electronic system will replace paper processes currently used for the City's 400+ full-time employees.

MOTION: To approve a contract addendum with NeoGov in the amount of \$20,000.00 for the acquisition of NeoGov performance management system.

Senior Expo - Booth Equipment Rental

The annual Germantown Senior Expo, presented by the Germantown Senior Citizens Advisory Commission, will be held November 1, 2018 at the Germantown Athletic Club and the Germantown Performing Arts Center.

MOTION: To authorize securing Hicks Convention Services in the amount of \$12,180.50 to provide all booths and specified equipment for the upcoming Senior Expo.

<u>Right-of-Way Acquisition - Tract 10a - Forest Hill-Irene Road Improvements</u>

The property subject of this item is the intersection of Bridge Forest Drive (the entrance into Bridge Forest Subdivision) and FHI and consists of 400 sq-ft of pavement. The City needs to acquire this area to properly tie in Bridge Forest Drive with future improvements of Forest Hill Irene Road.

MOTION: To approve the acquisition of real estate and/or easements from the Bridge Forest Homeowners Association for the total lump sum amount of \$1,000.00 for Tract 10A in accordance with the terms of the purchase agreement and authorize the disbursement of the purchase price to the seller and of other sums required of the City under the purchase agreement or otherwise to effectuate the purposes of the purchase agreement.

Motion by Mr. Barzizza, seconded by Mr. Owens, to approve the consent agenda as read.

<u>Wireless Transmission Facility Modification - T-Mobile Equipment Upgrade (8151 Poplar Ave. – Our Lady of Perpetual Help Catholic Church)</u>

Crown Castle has an existing cell tower situated on property that is leased from the Our Lady of Perpetual Help (OLPH) Catholic Church, on which T-Mobile Wireless is one of the current service providers. The lease agreement between the OLPH and Crown Castle allows for the maintenance, placement, updating or replacement of equipment as may be needed on the existing tower structure.

Motion by Ms. Gibson, seconded by Mr. Barzizza, to approve the request allowing six replacement antennas

and associated equipment on an existing tower for T-Mobile V facility located at Our Lady of Perpetual Help Catholic Church a	C
