NEW BUSINESS

Facility Rental Policy Amendments:

Parks Director shared the need to amend the Farm Park Rental Agreement policy for Pavilions, Pickering Center and Farm Park rentals. This will include adding rules to the current agreement to require the renter to come to the Parks department to fill out agreement and pay for facility rental and show a drivers license and be 25 years old with approval from the Parks Director. Alcohol policy will be added as well.

III. Bobby Lanier Farm Park, Inc. Project – Director Pam Beasley

As the Staff Liaison to the BLFP, Inc. Director Beasley presented a video of the vision of the BLFP, Inc. and the future of the Bobby Lanier Farm Park. She provided information to the commission regarding burning down of the house and the coordination with the City Fire and Police department would have. This would provide necessary state training for both fire and police departments. The house is beyond repair due to years of black mold build up.

Her recommendation was to remove the structure to make way for a large outdoor kitchen for cooking classes and fundraising dinners.
