# **Appointment – Shelby County Board of Equalization**

The task of the Board of Equalization is to examine, compare and equalize the assessments of the Shelby County Assessor's office when appeals are made. The Board is comprised of nine members. The Memphis City Council elects three members. Three members are elected by the County commissioners. The City of Bartlett, Town of Collierville and City of Germantown appoint one member each.

MOTION: To appoint Floyd R. Rumage as the City of Germantown representative to the Shelby County Board of Equalization for a term of two (2) years to expire on April 30, 2022.

# Competitive Sealed Proposal Authorization – Recreation Software and Wells/Pumps Rehabilitation

The City's procurement policies and practices require the use of competitive sealed bids for the purchase of most goods and services. In some cases, the competitive sealed bid process may be either impracticable or not otherwise advantageous to the City due to the complexity of certain technological products or the unique nature of certain services. In such cases, the Board may authorize the use of the competitive sealed proposal process.

MOTION: To authorize the use of the competitive sealed proposal process for procuring maintenance for recreation management software services and rehabilitation services for wells and pumps.

# 2020 Legislative Agenda

The administration works closely with our representatives, senators, the TML and our lobbyist to support or oppose any legislation based upon its impact to the City. The Tennessee Municipal League (TML) District 8 meeting was held on December 10, 2019, in Millington. At that time, elected officials and city/town staff from the area were provided with an overview of the upcoming General Assembly session and a review of the key legislative priorities and issues by the TML staff. On December 19, 2019, Mayor Palazzolo held a legislative luncheon at Germantown City Hall with our state representatives and senators to recap last year's session and preview the next.

# Agreement – Revised GMSD and Taylor Land Investors Land Exchange

The revised Land Exchange agreement between the Germantown Board of Education and the City now involves a third-party, Taylor Land Investors, to further the objectives of all parties. The following is a summary of the key elements of the exchange.

1. First Parcel. The City will deed 21.8 acres of Houston Levee Park to GMSD and retain 3 acres in the southwest corner of the park for parkland. GMSD intends to use the 21.8 acres for school-related recreational and school athletic uses.

- 2. Second Parcel. GMSD will deed 12 acres to the east of FHES to the City. The City intends to manage this property as a natural open space. In the event GMSD experiences enrollment growth above capacity, GMSD may demand reconveyance of this parcel at no cost.
- 3. Third Parcel. Taylor Land Investors will deed 5 acres along the northern border for the location of City-owned public utilities. Upon the approval and execution of the agreement, the City will work towards the design and construction of an elevated water tower on the Third Parcel.
- 4. Fourth Parcel. GMSD will deed 3 acres to the east of FHES to Taylor Land Investors. The Fourth Parcel is adjacent to the land proposed by Mr. Duke for single-family home development.

Motion by Ms. Gibson, seconded by Mr. Janda, to approve a revised agreement with the Germantown Board of Education and Taylor Land Investors, G.P., whereby the parties to the agreement would convey between and amongst themselves a total of four parcels as detailed in the Land Exchange Agreement.

Motion by Mr. Massey, seconded by Mr. Sanders, to suspend the rules to allow for open debate.

ROLL CALL: On original Motion by Ms. Gibson, seconded by Mr. Janda, to approve a revised agreement with the Germantown Board of Education and Taylor Land Investors, G.P., whereby the parties to the agreement would convey between and amongst themselves a total of four parcels as detailed in the Land Exchange Agreement.

### **Agreement – Revised GMSD Land Use**

The revised Land Use Agreement is a supplement to the revised Land Exchange Agreement between the Germantown Board of Education, Taylor Land Investors, GP, and the City. The revised Land Use Agreement addresses the specific details of which entity has primary and secondary use of shared facilities on the First Parcel behind Houston High School (HHS) during the term of the agreement.

Motion by Ms. Gibson, seconded by Mr. Janda, to approve a revised Land Use Agreement with the Germantown Board of Education which defines the prioritized use of facilities on the First and Second Parcels as covered in the revised Land Exchange Agreement.

Motion by Mr. Massey, seconded by Mr. Sanders, to have a work session and postpone this item until the March 9 regular meeting of Board of Mayor and Aldermen.
