Care Act money is not in the FY22 budget. Alderman McCreery is hoping a significant amount can be added to the stormwater fund for improvements.

Andy Sanders:

- In addition to a new Stormwater Commission, there will be the introduction of a Utility Commission as well. This commission will act similarly to the Stormwater Commission, and will value the input of residents in the Utility program processes in Germantown.
- The proposed Stormwater User Fee will increase from \$3.25 to \$9.00 monthly. The average stormwater rate will be an increase of \$69.00 annually per resident. From this fund, there will be \$800,000 of capital improvements by the stormwater fund. As it stands, there is not funding for stormwater and it is channeled from the general fund.
- Information to the public regarding the proposed Stormwater User Fee increase will be available on multiple platforms included in utility bill, newspaper, website, and social media.
- National Public Works Week is May 16, 2021 to May 22, 2021. Public Works celebrated Public Works Day with staff and honored Bobby Carter, who is retiring after 42 years with the City of Germantown.
- Air Quality Control Program Ordinance updated to reflect new regulations as implemented by the State of Tennessee.

COMMISSION MEMBER REPORTS:

Terri Johnson:

Information and communication to the public regarding the Stormwater User Fee increase is key!

Claudio Meier:

An article report in BBC Environmental and Science News found sewer overflows discharge micro plastics into rivers. They also found that sludge found in waste water treatment plants applied on agricultural fields contains a high number of micro plastics. There is not much evidence that micro plastics are bad for human health but they do have an impact on organisms in the river and the sea.

Jimmy Davis:

There was a second breach found near Davis Fields where Byhalia pipeline is going to go. Davis would like to speak with Schoefernacker about this issue. There was a report made to the Memphis City Council from CAESAR, and there should be more detailed report in the weeks to come.

OLD BUSINESS

Claudio Meier: A few months ago there was the potential of a tornado. There is no designated shelter in Germantown.

- ➤ The FAC stormwater subcommittee previously met to discuss the stormwater management fee. This fee has not changed in 11 years. There is a drainage deficiency in Germantown and residents are not able to give their recommendations and implementations on how to make improvements. This commission would be beneficial to the stormwater processes.
