
#### PUBLIC ASSEMBLY AREA (PAA)

Mr. Pouncey stated that the Public Assembly Area is an area within Morgan Woods that will be dedicated to outdoor public events. As provided for in the Master Plan for the Germantown Civic

Club Complex, the facility will provide seating, lighting, a stage, access (both emergency and pedestrian) and other supporting amenities. All users must abide by the parks Rules and Regulations developed by the Parks and Recreation Commission. In preparing the design, staff met with many stakeholders to understand their needs. The Board of Mayor and Alderman had \$250,000 in the CIP budget this past year and the plans can now go out for bid.

On the design board, Mr. Pouncey highlighted the road that goes down beside Harry and Becky Cloyes house by the railroad track and comes down to Morgan Woods. Then, he pointed to a path that goes to the Charity Horseshow arena. There is a walkway that will go back to the Soccerplex behind Germantown Elementary. He mentioned the parking area at that location.

Next, Mr. Pouncey highlighted a "depressed area" that serves for a 300-seat seating area and passed around the material that will be used, which can be easily cleaned by washing it down or blown. The material is concrete but made to look like stone. Railings will be placed in the middle and on the sides and lighting will be installed. Seating will be wide enough for lounging back and smooth enough for chairs. This spot was chosen because it is situated within large "canopy" trees that cover the stage. There a various position options for seating, theatrical and orchestra events. In order to move forward with the seating, there has to be emergency access for an ambulance, fire truck or some other necessary vehicle. Mr. Pouncey highlighted a spot close to Oceanview Farms, which the city will not take over until December, which means that the Shakespeare Company cannot use the space until then. This area is also well-screened and can be used as a staging area for trailers, equipment, props, changing costumes, etc. Mr. Pouncey also discussed options for entering, exiting, handicap access, and parking for the Public Assembly Area.


