Pam Beasley, Parks & Recreation Director, shared information about the Tennessee Smart Yards program. This included examples of personal actions toward gaining Tennessee Smart Yard Certification and how The City of Germantown implements these practices.

**Commission Member Reports:**

Topics that were discussed by the commission include change in weather, ideas for the Miller Farms ditch and the importance of green infrastructure in Germantown.
