The percentage of vacant retail not paying rent is 2%. Doing business in Germantown provides public safety and a high per capita spending provides incentive as does Grmantown spends in Germantown.

EDC members are encouraged to visit businesses and introduce themselves and to see how we can help them grow or maintain. We can ask them if they would like to be profiled and we should recommend enrollment in the Chamber of Commerce.
