Phase 2

6. Project Updates:

a. "Amalgamation" Temporary Artwork Display in the Community Library: Cat Peña reported that the installation of *Amalgamation* occurred on August 5th, 2024. A community workshop will be held on Saturday, September 21st from 11a.m. to 1 p.m. in which Sharon and Charles Havelka will work with community members of all ages to make a traditional paper dragon centipede kite. The kite will be suspended from rafters for a short during.

Cat Peña asked for 2 volunteers to assist with the workshop. Linda Reyle volunteered to assist with the event. One volunteer is still needed. Chairwomen Littlejohn asked that promotion of this event focus on that community members will be making one large kite together rather than making a small kite to take home.

Commissioner Kevin Young requested that Valerie Calhoun be contacted about this project to help raise awareness about this project.

b. Creative Crosswalks:

Cat Peña reported that Phase 1: Farmington Blvd. & Wolf River Blvd. has been delayed because the initial dimensions did not include the turning lane. Due to an increase in the length there will be a slight increase in the budget for this crosswalk. The increase will be covered by the Public Art Fund. She anticipates that the installation will occur during the week of October 7, 2024.

The completion of Phase 2: Riverdale Road & Wolf River Blvd. has been delayed due to the reliance on the completion of the Milling and Overlay CIP project on Wolf River Blvd. The Engineering department is currently seeking bids for the project. The bids will be opened on September 13th, 2024. The work is not anticipated to be completed until May 2025. The date of completion for Phase 2 is anticipated to occur in the first quarter of FY26.

7. Reports:

- a. Chairwoman's Report: Amanda Littlejohn Chairwoman Littlejohn thanked the commission for their thoughtful comments during the approval process of the proposed artwork for the Standard Germantown. In addition she asked that the commission consider the accessibility and experience of individuals who have limited abilities or disabilities and are not traditional public art viewers on future projects.
- **b.** Alderman Liaison Report: Mary Anne Gibson- Alderman Gibson shared information about several events including:
 - Harvest Moon Festival on October 19th from 12-6 p.m. at the Farm Park. It will be a ticketed event and tickets are \$10.

- Neighborhood Preservation is holding a summit called "Neighbors in Action". It will be held at the Great Hall on September 24th. from 5:30-8:00 p.m.
- The Economic Development Commission is holding the first ever "Business Owners Summit". The event will connect staff at ECD with business owners. The event will be on October 29th from 8:30- 1:00 p.m. at the Great Hall.
- "Lights on the Farm" on December 7th at the Farm Park. The lights will remain along the carriage trails for people to enjoy through January.
- c. Beautification Liaison Report: Albert Pope- Commissioner Pope wanted to remind the group that Thanksgiving falls on the last week of November this year and the Holiday Lighting Ceremony will be the last day Friday of November. The location of the Holiday Tree is currently being determined due to timing of construction projects around City Hall. Applications for the Lighting Contest will open during the week of Thanksgiving and judging will be on December 11th. There will also be some additional holiday decor along the roadways this year due to a set of new MLGW standards for banners on light poles.
- d. Design & Review Liaison Report: Christopher Schmidt- Commissioner Schmidt reported that the subcommittee met to review the Germantown Collection revised landscape plan. The DRC also approved a Chipotle at the old Backyard Burger on West Street. Lastly there was a Sketch Plan Meeting to review Phase 3 of The Standard Germantown which would include a boutique hotel that would be located at the corner of Kirby Parkway and Poplar Avenue.
- e. Parks and Recreation Liaison Report: Kevin Young- Parks & Recreation Commissioner Young shared a Parks & Recreation meeting is scheduled for later this week.
