## **Call to Order**

Chairman Stephen Wilensky called the January 4, 2011 meeting to order. The meeting was held in the Great Hall Conference Center.

#### **Approval of the Minutes**

Chairman Wilensky asked for a motion to approve the minutes. Mr. Erskine motioned to make changes in the minutes. Motion to approve the December minutes was made by Mr. Clint Hardin with changes as presented and seconded by Mr. Ayerst and all were in favor.

### Club Reports:

Mr. Cromis spoke briefly on the Athletic Club Operating Results concerning Revenues and Expenditures, his power point presentation showed a loss in Operating Income of \$189,248.00 in FY10 compared to a loss of \$818,936.00 in FY08 and a loss of \$545,747.00 in FY09. His presentation showed at the end of November for Year-To-Date Operating Income for FY11 the Club is at \$131,659.00 meeting 25% of our budget. He also noted that for the month of November we were budgeted to be at a \$29,000.00 loss where actually we had an income of \$17,104.00 which is significant for the Club.

Mr. Cromis discussed upcoming topics, events, and services and updated the members on the dehumidifier's due to be replaced in the next few months. He has spoke to Mr. Douglas the Supervisor over maintenance and the equipment is on order and should take approximately 4 months to install. This will take place in the spring and early summer.

There was discussion among the members and suggestions for a dedicated work session with the Commission Members and staff for bringing in information on different options before the decision is made on leasing the new fitness equipment.

Ms. Dennison the Club marketing representative discussed the upcoming Open House on January 13 and the discounts that will be offered as well the advertisements she has promoting the Open House. Curt expressed how important this event is to the Club and how last year the Open House generated approximately \$40,000.00 in revenue alone.

Mr. Lawton, the City Administrator discussed handouts he presented to the Commission members pertaining to their roles as a Committee Member for the City:

Mr. Lawton promised to come back to the Committee later in the year after the retreat with the City's Administration with their plans for this year's goals to reach the 2020 Vision.
