Alderman Mike Palazzolo Report – Alderman Palazzolo stated that Ordinance 2011-08 – Amendments to the Code of Ordinances, Chapter 14, Permanent Signs, Regarding Projecting Signs, had the first reading and set a public hearing date. The amendment to this ordinance would create a category and regulations for "projecting signs" and allow signs to be hung from supports extended from the building façade on office and commercial establishments in the Old Germantown district.

This amendment was in response to a proposal from Salvaggio Development Group for a sign on the Brownstone building on Poplar Pike within the Old Germantown district. The proposed sign projects from the front wall of the building, to the right of the front entrance, and lists the building tenants in a directory format.

Neighborhood Services Report – Joe Nunes reported that the entire neighborhood services department has been working on the new sanitation roll out.

CONA Report – David Jackson reported that the next CONA meeting will be held September 22 at 7 p.m.
