

# GERMANTOWN PUBLIC SAFETY EDUCATION COMMISSION

## August 6, 2012 minutes

The August meeting of the Germantown Public Safety Education Commission was called to order by Jonathan Frase, Chairperson, in the Administrative Conference Room, at 5:35 pm

### REPORTS

- Police Report – Lt. Angie Lewis: A school requested a child safety seat check. We are going to see if we can arrange for police officers to check the seats during car pool. The next Drug Take Back is September 29 (Saturday) from 10:00 to 2:00. We received a request for purchase of CPR training equipment.
- Fire Report – Jody Dwyer: No report
- Safety City Review – Ron Roberson: Other than a few hiccups, Safety City was a well organized and successfully accomplished event. Ron referenced the evaluation and commented on the remarks and suggestions. We will need a new organizer of volunteers. Lillie Kay said the responsibilities could be divided among five or six helpers. It was the consensus of the commission to again accept Ron's invitation to host Safety City 2013 at the Germantown Church of Christ. The dates are June 10 to 14.
- BMA – Greg Marcom: Greg updated us on the municipal school issue. October 1 leadership Germantown will host the School Board Candidates Forum. On October 16 there will be the Alderman Candidates Forum. Both will be held in the Council Chambers and will begin at 6:00 pm.
- Traffic Engineer - Jonathan Smith: The traffic signal LED and timing project is near completion. They are working on some school zone issues, the entrance to Methodist Hospital and looking at the accident/crash location statistics
